Cookies

Cookies are files with small amount of data that is commonly used an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your computer's hard drive.

Our website uses these "cookies" to collection information and to improve our Service. You have the option to either accept or refuse these cookies, and know when a cookie is being sent to your computer. If you choose to refuse our cookies, you may not be able to use some portions of our Service.

Which information is collected

Personal information during the registration process

Personal information to update your back office

To update your personal Back office we collect your full name, phone number, e-mail address and date of birth do enable the authentication.

How do we use this information?

We use the information to create a composite profile of our valuable members, so they can utilize our service modules. Membership does not guarantee access all modules. We use this information to verify the authenticity of each user and to prevent and verify the creation of multiple accounts. We use your information to provide you with the information you need about our services, promotions, local events & to inform you about our policies, terms & conditions. Beyond profile analysis, we use your information for replies when you contact us. Location information, if provided, will be used to meet local events or meet-up in your area.

Sharing of information in Lending

We share your screen name (username) with other SirioCoin members while you make lend or redeem requests in the system. For privacy purposes, members remain anonymous on the site & are identified only by their chosen screen names.

Sharing your information during Affiliate

During Affiliate we share your screen name (username) with other SirioCoin members while you send your affiliate (referral link) to other future or potential SirioCoin members.

How can you share or delete information about you

Use the Activity Log Tool to manage the information you share with SirioCoin. We will retain your information as long as your account is active or as needed to provide you products & services. Information associated with your account profile will be kept until your account is deleted. You can delete your account any time.

Risk Disclosure

For lending, we pool the member's funds for our volatility software and trading-bot. This is in case we make a loss with trading or there is any technical failure of the platform or a sudden drop in asset value that we are holding.

In lending, the member agrees that they cannot terminate their contract before the term plan has ended which the member has chosen.

All lending activities are reported in US-Dollars consequently members will receive all capital and interest payments in US-Dollars and not in SirioCoin which was initially lent by the member.

Members should note that there is no guarantee of daily profit for lending.

SirioCoin reserves the right to institute and implement new rules of paying interest and capital should SirioCoin lending fail in any way.

SirioCoin reserve the right to change the lending algorithm, the interest payment and capital back system.

There is no guarantee of investor's capital if the lending system fails due to any of the reasons mentioned above.

Account and personal security

We work hard to help keep your account secure and protect your personal information. By joining SirioCoin Back office, Lending platform and website, you agree to use your email address and username. You may not publish the personal information of others in public view. It is not allowed to have multiple SirioCoin accounts. If we detect you have multiple accounts you will be asked to remove them or face suspension. This is to prevent Sybil Attacks and abuse of the system in general.
